**The Carotid Restraint Training Institute (Hosted by the Carlsbad Police Department)** is proud to present this professional two-day Carotid Restraint Control Hold instructor course. Even if your agency does not permit the use of vascular neck restraints, every agency should have a subject matter expert on staff. The Law Enforcement Carotid Restraint Control Hold is a Bilateral Vascular Restraint and is NOT a respiratory "choke hold." This course is designed and instructed by sworn and retired veteran law enforcement trainers to create competent and expert bilateral vascular restraint instructors at the agency level. The CRTI curriculum is based on recent bilateral neck restraint studies and publications by Dr. J. Mitchell, Ph.D. (2011), Dr. J. Pi, M.D. (2010), and recommendations as outlined in the (2007) "National Study on Neck Restraints in Policing" by the Canadian Police Research Centre (Dr. C. Hall, M.D.). This program is also fully endorsed by Dr. Ron Martinelli, Ph.D. who is a nationally recognized Forensic Criminologist & Certified Medical Investigator specializing in police use-of-force. Attendees successfully completing this course will be certified as a Carotid Restraint Control Hold Instructor by this insured training presenter for a period of three years.

**Topics Covered:** This course was designed to meet or exceed law enforcement and state P.O.S.T. training standards. Course topics include: Neck restraint history, types of neck restraints, objectives and goals, medical opinions, anatomy and physiology, effects on the body, risk factors, post application side effects and care, follow-up actions, excited delirium, technique development, recognizing submission, defense against neck restraints, instructor development and more.

**Prerequisites:** None. This Carotid Restraint Control Hold Instructor course is for new or current DT instructors.

**Requirements:** Students must be active Peace Officers, Correctional Officers, Probation/Parole Officers or a civilian law enforcement trainer employed by a federal, local or state agency, or certified training center. Students must be in good physical condition, free from any pre-existing injuries or conditions that may become aggravated with dynamic and repetitive defensive tactics type training. Students will **NOT** be intentionally rendered unconscious during any portion of this course. Students must pass a written and physical performance examination to receive instructor certification.

**Suggested Items:** Loose fitting athletic or duty attire is required (no shorts or tank tops). BDU style pants and mat room shoes are recommended (No outdoor shoes or boots on the mats. Socks are okay). An empty duty belt with keepers, handcuffs and a handcuff key is also required. Red or blue training guns are acceptable.

Students will receive an electronic or hardcopy Technique Manual, PowerPoint presentation, Carotid Restraint Resources, Instructor Certificate & Challenge Coin upon successful completion.
