		Instructor Update, 29448-Firearms Instructor Update, 29450-Physical Training Instructor Update, and 29452-Use of Force Instructor Update. Updated courses must be completed by 2029. POST suggest to wait till near the January 2029 deadline date to complete, that way you don't have to take update course again till 2033. Updates are done every 4 years. 		School Resource Officers in each California Schools. Bill failed last year perhaps due to budget issues. AB 85 Law Enforcement Cooperation with Immigration Authorities (Failed). AB 992 Modern Policing Degree, has been pushed out to July 2029. AB 1489 bill would require a law enforcement agency that issues a firearm to a peace officer it employs to have a policy prohibiting that officer from carrying the firearm issued by the agency with a blood alcohol concentration greater than 0.00%, whether the officer is on duty or off duty (Pending).
