1.	Presentation	Online Presentation: Police Promote Retired Captain Borrello, Andrew. 8-hour promotional preparation and career development. Open for all ranks. Andy Borrello 951-532-6733, policepromote@gmail.com. Training for this course will be held at SDI HIDTA Building 11/19/2025 8am-5pm (\$150). 1989 transitioning to Sergeant, he put all his preparations in a binder in sections. He did studies in psychology, communications, teaching, and completed a master instructor program. His course is unique, very simple and achievable; that you can use it right away out the door. During the 8-hour training we cover mindset, prepare and practice. Class is very interactive and really participating. Students can still reach out to the instructor for questions and follow up after the class and interview. Have his door open to help.

		Law Enforcement Group are all licensed financial professionals; the group is an association with one of the largest financial groups, Equitable Advisor Financial Life Insurance Co. Their focus is educating officers on financial wellness, making sure that the officer is fully aware of all the worlditary disposal, good habits, and best practices to really be fulfilling life and remain financially sound. This all started with two divisional chiefs of CHP stressed concern about financial wellness for their troops. They were doing a great job with physical wellness, mental wellness, and social wellness. One element seemed to be missing, financial wellness. This one-hour course goes over 11 topics. Create a Budget, Credit Card Debt, Emergency Fund, Overtime, Investment Basic, Supplemental Retirement Plans, Maximizing CalPERS Retirement Plans, Income Replacement and CalPERS Death Benefits, Life Insurance Protection, Pre-Retirement, and Safeguarding Your Choices. Teach younger officers about their pensions, what is the difference between a classic member and a PEPRA. The importance of supplementing their pensions. Importance of having a will in place, power of attorney, and living trust. This course is tailored to agency benefits. They offer this course at no cost, whatsoever, to the agency. We choose to do these in person. They travel throughout Southern California. Course is one hour cover more details on 11 topics. The overview is half hour (lineups). The goal of the course is to help reduce financial stresses in the officer's lives, improve relationships at home, and improve their job performance. Civilians are welcome to attend course. Majority of the topics covered are general financial wellness that applies to civilian and dispatchers. Discussion on pensions are for the officers.

4.	POST Report	We are in July, and in the POST Force Course Modification stage for all the training courses in California. If your course was approved in an odd year 2023, it will be forced into modification in two years 2025. Purpose of force modification is to keep instructor list updated, and any changes in policy updated. Check your safety plan, admin page, instructor and outline page and make sure it is current to standards. Read Dan's comments and make the corrections (every outline must have a revision page and make sure revision date and number is up to date). POST is monitoring 29 law enforcement bills. 6 of the 29 are
		administrative items where a training manager does not have to worry about. See below: AB 421 Immigration Enforcement: prohibitions on access, sharing information and LE collaboration. This bill would prohibit California law

enforcement agencies from collaborating with, or providing any information in writing, verbally, on in any other manner to, immigration authorities regarding proposed or currently underway immigration enforcement actions when the actions could be or are taking place within a radius of one mile of any childcare or daycare facility, religious institution, place of worship, hospital, or medical office. The other side of it is AB 85 LE: cooperation with immigration authorities. Under current law, a law enforcement official has limited discretion to cooperate with immigration authorities, and may only provide information regarding a person's release date or transfer an individual to immigration authorities without a judicial warrant or probable cause determination if the individual has been convicted of specified crimes, including, but not limited to, serious and violent felonies, as specified, and only if doing so would not violate any federal, state, or local law, or local policy. Notwithstanding those provisions, this bill would instead require law enforcement officials to cooperate with immigration authorities by detaining and transferring an individual and providing release information if a person has been convicted of a felony.

SB 274 Automated license plate recognition system. subdivision of the state, a city, a county, or a city and county, including, but not limited to, a law enforcement agency, from selling, sharing, or transferring automated license plate recognition (ALPR) information, except to another public agency, and only as otherwise permitted by law. Current law defines ALPR information as information or data collected through the use of an ALPR system. This bill would, in compliance with specified laws, prohibit a public agency from using an ALPR system to gather geolocation data at specified locations for immigration enforcement purposes and retaining ALPR information for more than 30 days, except in specified circumstances.

SB 574 Artificial Intelligence in officer reporting writing. If you have an AI generated report and must make any changes. It is required for the officer to keep an original and keep the change.

AB 992 Peace Officer must have one of the six qualifications to be hired as a peace officer. Modern Policing Degree, Associates Degree, Bachelors Degree, 2 years of military experience, 2 years of law enforcement experience at another state, professional certificate from policing certificate (police academy). If you do not have any of those five you must get a Modern Policing Degree in 3 years. Required by 1/1/2031.

Instructor Update, 29448-Firearms Instructor Update, 29450-Physical Training Instructor Update, and 29452-Use of Force Instructor Update. Updated courses must be completed by 2029. POST suggest to wait till near the January 2029 deadline date to complete, that way you don't have to take update course again till 2033. Updates are done every 4 years. For an instructor to get the update course; instructor must teach the update
