1.	Presentation	Riverside County DA Child Exploitation Team (Human Trafficking). Liam Doyle 951-741-9445. Email Liamdoyle@rivcoda.org . Investigator Doyle is part of the Riverside County, DA Office. The Riverside County Exploitation Team is part of San Diego's internet crime scene, Children Task Force for 7 years, in the last 5 years as the supervisor of the team. This course was developed out of master instructor school. Went through GTA and MICC and built this 32-hour online child exploitation course. POST certified, restricted to law enforcement only. Students are exposed to child exploitation, they are exposed to suspects as well. Students must have a department approved device, thumb drive, something they can contain off of Wi-Fi. They cannot use anything that is personal because they're going to be sent abuse material from these suspects. What sets this course apart is the student develop criminal cases in the class and then make the arrests as soon as they return to their agency. Students spend 10 hours processing in the course of the 32 hours, doing actual work getting real time feedback.

		Free no cost tuition. His agency allows him to travel and whoever is hosting covers his lodging and per diem. Student caps at 30, accepts 35 enrollments. SDTMA approves using SDTMA funds to host this course. SDTMA members have priority registration.
